## Information about your application to the dormitory

## Dear applicant!

Our residence consists of 103 single and 2 double rooms (which can also be occupied individually) spread over 6 floors with a large communal kitchen.

The rooms are between 10 sqm and 18 sqm (double room). The rent is between 360 and 600 € (double room), including all utilities. The proportion of foreign students should be about 30%. The period of residence is limited to four semesters, but can be extended to up to 10 semesters through activity and commitment.

The dormitory of ESG Cologne is a residence for students of Cologne universities. It is characterized by its international character and cultural diversity. It thrives on the commitment and interest of its residents. In our dormitory, students live together in close spatial proximity - this requires mutual consideration, understanding and tolerance, but also offers the possibility of an active and communal life together. The assumption of responsibility and the fulfillment of duties is expected.

This includes, for example, participation in working and project groups or the planning and implementation of events that enrich life in the ESG and dormitory. Participation in the house assembly, our dormitory convention (once a semester), is also obligatory. If you are just looking for a room in a central location, that is not enough to get a place in our dorm.

The dormitory is located under one roof with the rooms of the Evangelische Studierendengemeinde. Active cooperation between the staff of the ESG Cologne and the residents of the dormitory creates a lively community. Everyone is invited to contribute to this community.

Our application committee, which consists of elected student representatives and the parish team, decides on your acceptance. According to our Christian understanding, we are open to all applications, regardless of religious, political and sexual orientation.

The application period for the summer semester runs from December 01 to January 15 at the latest, and for the winter semester from May 01 to June 15 of the respective year at the latest. No late applications can be considered after the application deadline. The application committee will decide on the allocation of a dormitory place promptly after the deadline. Move-in dates are April 1 or October 1 in the following year.
